The post applied for should be mentioned clearly on the envelope.**

The engagement of Young Professional-I, II and SRF will be on purely temporary basis and the selected candidates shall not have any right to claim for regular appointment under ICAR-NIHSAD, Bhopal (M.P). Initial engagement of ICAR Young Professional-II shall be one year which is extendable for two more years (one year at a time) subject to requirement of the Institute and satisfactory performance of the candidate following evaluation. The ICAR NIHSAD, Bhopal will hold no responsibility for payment of salary/regular appointment etc. after expiry/termination of the Scheme.
3. Candidates who wish to appear for more than one number of post Young Professional-I, II and SRF are requested to submit their applications separately in the prescribed format.
4. **All the Original Degree/Provisional Degree certificates, marksheets and experience certificate (if any) will have to be produced at the time of interview.**
5. **Those who do not possess PDC/Original degree certificate by the closing date of application need not apply.**
