### Recruitment of Non-executive posts at Malanjkhand Copper Project

# NOTE:

The required years of experience shall be reckoned from the date of attaining Mining Mate certificate of competency for metalliferous Mines (Un-Restricted) issued by DGMS.

#### 2. Date of Reckoning:

The date of reckoning for computation of eligibility criteria towards age, qualification, experience etc. shall be **01.08.2024**.

- 3. <u>Age</u>: Maximum 35 years as on 01.08.2024.
  - (i) The maximum age limit is 35 years as on **01.08.2024** for General & EWS Candidates.
  - (ii) The maximum age limit is relaxable by 5 years for SC/ST candidate & 3 years for OBC (Non-creamy layer) candidates.

#### 4. <u>Reservation</u>:

(i) Reservation of posts for SC/ST/OBC (Non-Creamy Layer)/Ex-Serviceman/Economically Weaker Section (EWS) candidates shall be as per the Govt. of India Directives.

- (ii) As the post of Mining Mate Grade-I are specifically for underground mines, therefore, no post is identified for Persons with Disabilities (PwD) for employment in the category.
- (iii) Candidates seeking reservation under EWS will have to submit an Income & Asset certificate issued by the Government Authorities. The prescribed format and the Competent Authority have been mentioned in DoPT office memorandum no.: 36039/1/2019.
- (iv) Wherein in any recruitment year, any vacancy earmarked for EWS category cannot be filled up due to non-availability of a suitable candidate belonging to EWS, such vacancies for that particular recruitment year shall not be carried forward to the next recruitment year as backlog and the vacancy will be filled by other than EWS candidate.

## 5. Mode of Selection

- (i) Mode of selection shall be through written test followed by Trade Test. Written Test shall be held in the form of multiple choice questions. Successful candidates in written test shall further go for Trade Test.
- (ii) The candidates, who secure minimum pass marks of 35% for SC/ST candidates and 40% for others in written test, shall undergo for trade test in the ratio of 1:3 of the vacancies.
- (iii) The weightage of the written test and trade test will be 80% and 20% respectively. Final merit list will be made based on aggregate of written test and trade test marks.
- (iv) The Trade Test shall be conducted on the same day for the successful candidates in written test.

#### 6. Centre for written Test

The likely date of written test and venue will be communicated through company's website. Candidates are advised to visit company's website <u>www.hindustancopper.com</u> from time to time for any change/update.

#### 7. Issue of Admit Card

- (i) Admit card for written test shall be sent through email only. Hence candidates are advised to ensure that they provide correct active email id in the online application form. All correspondence with the candidate shall be done through e-mail & Company's website only.
- (ii) Candidates are therefore advised to visit regularly on our website for latest updates. The Company shall not be responsible for any loss of email sent due to invalid/ wrong email ID provided by the candidate.

#### 8. Application Fee

- (i) The General, OBC & EWS Candidates are required to pay non-refundable application processing fee of Rs.500/- (Five Hundred Only) and all other candidates are exempted from paying fees.
- (ii) The application processing fee plus applicable Bank charges shall be paid by the applicant using the Payment Gateway / NEFT On-line Transfer through HCL's website only. <u>No other form of remittance shall be accepted.</u>

#### 9. Emoluments

- (i) Candidates selected as Mining Mate Grade-I will be placed in the pay scale of Rs. 28430-3%-59700/- (T-08 grade).
- (ii) Besides Basic Pay, Dearness Allowance (IDA pattern), Allowances, Company accommodation(subject to availability), LTC, Medical facilities, Reimbursement of conveyance expenses, Contributory Provident Fund, Gratuity, etc. will be admissible as per Company rules in force from time to time.

#### 10. Probation

Candidates selected as Mining Mate Grade-I will be on probation for a period of Six months. On successful completion of probation period, they will be confirmed to the post.

## 12. Documents

- (i) Self-attested photocopies of the following documents should be attached with the online generated application form.
  - (a) Matriculation / Secondary Certificate as proof of Date of Birth.
  - (b) Marks Sheet OR Certificate of: Matriculation / 10th / Secondary / Diploma in Mining, as applicable, in support of qualification.
  - (c) Mining Mate Certificate of competency (unrestricted) issued by DGMS for metalliferous mines.
  - (d) Valid First Aid Certificate issued by the Competent Authority.
  - (e) Experience certificate as applicable.
  - (f) Caste Certificate in the prescribed format issued by the Government Authorities, if applicable.
- (ii) If the above documents are not received within the due date, the candidature of the applicant shall not be considered.

#### 13. Internal Candidates

- (i) The existing serving employees of Hindustan Copper Limited who are fulfilling the requisite eligibility criteria and desirous of applying against the advertised posts shall also have to submit their application through proper channel.
- (ii) No application fee shall be charged from the employees of the company.
- (iii) The prescribed age limits will not apply in such cases.
- (iv) Company employees appearing for Written/Trade test shall be treated as on tour/duty and their travelling allowance/attendance as the case may be, will be regulated as per rules of the company.

#### 14. Medical Fitness

The final placement of the candidate in the Company will be subject to the selected candidates being found medically fit by the Company's Medical Officer/Board for the post(s) for which they have been selected. Where there is no Company's Medical Officer, medical examination will be conducted by an approved Government Hospital/Medical Board. The decision of Medical Board constituted by the Company will be final and binding.

#### 15. How to Apply

- (iii) Interested Candidates can apply more than one post, subject to the fulfillment of eligibility criteria as mentioned at point No 1. Candidates have to pay separate application fee as per details mentioned at point no 8 if the individual candidate decides to fill application for more than one posts.

- (iv) To complete the online application process and get the Application number, it is mandatory to put in all the relevant information such as qualifying degree details, percentage of marks, email address and mobile no., address for correspondence, soft copy of scanned photograph and signature (JPEG). Therefore, applicants are advised to keep such information ready before applying online.
